- [1] **Abortion Reporting Requirements (SB 1304)** Requires abortion providers to report abortion statistics to the Department of Health Services to provide an overview of abortion in Arizona. **Passed House 35-20. Passed Senate 17-12. Signed into law by Gov. Brewer on April 21, 2010.**
- [2] **Prohibition on Taxpayer-Funded Abortion Coverage (SB 1305)** Clarifies Arizona law prohibiting taxpayer funding of abortion to ensure that government entities do not provide insurance coverage for elective abortion and opts Arizona out of abortion coverage in any insurance exchanges created through the new federal healthcare plan. **Passed House 35-20. Passed Senate 17-11. Signed into law by Gov. Brewer on April 24, 2010.**
- [3] **Human Egg Provider Protection Act (SB 1306)** Ensures women are given full information before donating their eggs and prohibits the sale of human eggs for cloning or similar research. **Passed House 36-23. Passed Senate 16-12. Signed into law by Gov. Brewer on May 7, 2010.**
- [4] **Ethical Treatment of Human Embryos Act (SB 1307)** Protects human dignity by prohibiting the sale of human embryos, destructive human embryonic stem cell research, human cloning, and human-animal hybrids. **Passed House 35-24. Passed Senate 16-12. Signed into law by Gov. Brewer on May 7, 2010.**
- [5] **Marital Preference for Adoption (HB 2148)** Gives a preference for children to be placed with a married mom and dad in adoptions through the State. **Passed House 35-22. Did not receive full vote in Senate.**
- [6] **Parental Rights (SB 1309)** Codifies the constitutional rights of parents to direct the upbringing and education of their children. **Passed House 33-24. Passed Senate 16-14. Signed into law by Gov. Brewer on May 10, 2010.**
- [7] **Divorce Reform (SB 1094)** Allows couples to request extra time to reconcile before their divorce is finalized and enhances the parenting information class to include the effects of divorce on adults and children. **Passed House 33-23. Failed Senate 15-12.**
- [8] **Child Prostitution (HB 2238)** Removes a defense for predators who engage in prostitution with a minor. **Passed House 59-0. Passed Senate 30-0. Signed into law by Gov. Brewer on May 7, 2010.**
- [9] **Religious Freedom, Land Use (HB 2596)** Protects the First Amendment rights of churches to be free from discriminatory zoning or land-use regulations. **Passed House 44-13. Passed Senate 17-12. Signed into law by Gov. Brewer on May 11, 2010.**
- [10] **Religious Freedom, Campaign Finance (HB 2490)** Exempts churches from registering as political committees when speaking about ballot measures. **Passed House 37-22. Did not receive full vote in Senate.**
- [11] **Individual Scholarship Tax Credit Reform (HB 2664)** Provides increased accountability and transparency in the individual scholarship tax credit program. **Passed House 36-23. Passed Senate 17-13. Signed into law by Gov. Brewer on May 10, 2010.**
- [12] **Corporate Scholarship Tax Credit Conformity (HB 2663)** Confirms the corporate scholarship tax credit program to the changes in the individual scholarship tax credit program made in HB 2664. **Passed House 36-23. Passed Senate 17-13. Signed into law by Gov. Brewer on May 10, 2010.**
- [13] **Tax Credit Donations Deadline (SB 1274)** Allows donations made to school tuition organizations to relate back to the previous tax year if the donations are made by April 15. **Passed House 33-24. Passed Senate 17-13. Signed into law by Gov. Brewer on April 28, 2010.**
- [14] **University Scholarship Equity (SB 1280)** Requires state universities to publish the criteria used for awarding scholarships and notify students in a timely manner to ensure fair and equitable access to scholarships for students from public, charter, private, and home schools. **Passed House 53-2. Passed Senate 27-2. Signed into law by Gov. Brewer on April 26, 2010.**
