MOBILIZING THE GRASS ROOTS DRIVING THE CONVERSATION

CAP's determination to raise a voice in the public square and speak out on issues that affect the safety and freedoms of Arizona families is a cornerstone of our commitment to you. This fall, a measure to legalize recreational marijuana (Prop 205) threatened to put impaired drivers on our roads and expose our kids and teens to dangerous high-potency forms of the drug.

We answered the call and took action.

With the odds against us, CAP engaged with community leaders and parents to expose the dangers of Prop 205. We hosted briefings, pastors' summits, town halls, and conference calls to unmask the hidden agenda and lies of proponents.

"We have found a strong ally coming alongside us as we stand for biblical moral values," says Mark Martin, Senior Pastor at Calvary Community Church. "Center for Arizona Policy's resources have enabled us to be equipped to educate our church and help us have a part in making a positive impact in our state."

Our voices together sparked a powerful grassroots movement that sent ripples across the state, forging lasting partnerships between CAP and the faith community, and directly resulting in the narrow defeat of this measure. Arizona now stands alone as the only state with legalization of recreational marijuana on their ballot this November to stand up and say "no!"

EXPANDING OUR REACH

Expanding our reach to new constituents was a core focus throughout the year. CAP's Community Relations Director Obed Escobar engaged with Hispanic pastors and students across the state to drive the conversation about Prop 205.

Obed's appearances on Spanish-language television reached tens of thousands of Arizonans who would have otherwise not been influenced.

We gathered more than 1,000 people to the State Capitol for a Prayer and Worship Rally to pray for our state and nation.

Our get-out-the-vote efforts reached more than 1.5 million Arizona residents through targeted social media and internet marketing campaigns.

Strong messaging, purposeful design, and precise targeting delivered our message efficiently and with the greatest impact.

Public engagement surged in 2016, and digital marketing analytics will allow us to hone the process for a higher rate of engagement in 2017 as we continue to expand our reach across a wide range of ages and groups.

STANDING UP FOR ARIZONA

CAP's work at the Arizona State Capitol saw 15 CAP-supported bills signed into law, including laws to prohibit the trafficking of aborted baby body parts and to double the Charitable Tax Credit.

This allows taxpayers to direct more tax dollars to foster care and adoption agencies, pregnancy resource centers, and other organizations that help the working poor.

CAP's advocacy also worked to prevent bad laws from being enacted. According to Josh Kredit, CAP General Counsel and VP, Policy, **"We lean in and listen as much as we stand up and defend."** We then advocate for you at the Capitol.

More than 50 potentially harmful laws failed in the state Legislature in 2016, many of which would have restricted school choice and infringed on the privacy rights of your children, while threatening religious freedoms.

There is much more work to be done as more harmful laws are proposed and these issues continue to challenge the values we hold to, but CAP promises to continue standing up for you and your family, and to be a stable voice in a shifting culture and during times of uncertainty.
