1 Page 1, between lines 1 and 2, insert:

2 "Section 1. Section 15-1861, Arizona Revised Statutes, is amended to  
3 read:

4 15-1861. Definitions

5 In this article, unless the context otherwise requires:

6 1. "Community college" has the same meaning prescribed in section  
7 15-1401.

8 2. "INDIVIDUAL CONDUCT THAT MATERIALLY AND SUBSTANTIALLY INFRINGES  
9 ON THE RIGHTS OF OTHER PERSONS TO ENGAGE IN OR LISTEN TO EXPRESSIVE  
10 ACTIVITY" MEANS CONDUCT BY A PERSON WHO, WITH THE INTENT TO OR THE  
11 KNOWLEDGE OF DOING SO, MATERIALLY AND SUBSTANTIALLY PREVENTS THE  
12 COMMUNICATION OF A MESSAGE OR PREVENTS THE TRANSACTION OF THE BUSINESS OF A  
13 LAWFUL MEETING, GATHERING OR PROCESSION BY DOING ANY OF THE FOLLOWING:

14 (a) ENGAGING IN FIGHTING OR VIOLENT OR OTHER UNLAWFUL BEHAVIOR.

15 (b) PHYSICALLY BLOCKING OR USING THREATS OF VIOLENCE TO PREVENT  
16 ANOTHER PERSON FROM ATTENDING, LISTENING TO, VIEWING OR OTHERWISE  
17 PARTICIPATING IN AN EXPRESSIVE ACTIVITY.

18 (c) PREVENTING ANOTHER PERSON FROM ATTENDING, LISTENING TO, VIEWING  
19 OR OTHERWISE PARTICIPATING IN AN EXPRESSIVE ACTIVITY THAT IS HELD AT A  
20 LOCATION THAT IS NOT A PUBLIC FORUM, SUCH AS AN AUDITORIUM OR LECTURE HALL.

21 ~~2.~~ 3. "Public forum" includes both a traditional public forum,  
22 which is any open, outdoor area on the campus of a university or community  
23 college, and a designated public forum, which is any facility, building or

1 part of a building that the university or community college has opened to  
2 students or student organizations for expression.

3 ~~3.~~ 4. "University" means a university under the jurisdiction of the  
4 Arizona board of regents."

17 EXPRESSIVE RIGHTS OF ANOTHER PERSON" insert "ENGAGED IN INDIVIDUAL CONDUCT  
18 THAT MATERIALLY AND SUBSTANTIALLY INFRINGES ON THE RIGHTS OF OTHER PERSONS  
19 TO ENGAGE IN OR LISTEN TO EXPRESSIVE ACTIVITY"
