



## “BAD BILLS” CONTINUED

### Educational Freedom

Seven bills designed to restrict parental rights to choose the education best meeting their children’s needs.

### Parental Rights on Sex Education

#### HB 2277/SB 1120

Mandates comprehensive sex education for K–12 in all public district and charter schools. Only allows parents to “opt-out” their children rather than “opt-in” their children to such classes.

### Other

#### HB 2657

Legalizes recreational marijuana leading to harms to children and public safety.

# 2019–2020 “BAD BILLS”



*The following bills were introduced in the 2019 or 2020 legislative sessions. All “bad bills” for 2019 were defeated, and as of this printing, all appear to have been defeated for 2020!*

## Life

### HB 2693/SB 1218

Repeals key lifesaving pro-life laws proven to meet women’s needs and save babies by authorizing non-doctors to perform abortions, repealing right-to-know informed consent waiting period and provisions, and allowing telemedicine abortions.

### HB 2854

Forces pro-life pregnancy centers to be licensed by the state and meet unnecessary government regulations in an effort to close those centers providing care to women facing crisis pregnancies.

### SB 1270

Allows a doctor or counselor to consent to a minor’s abortion rather than a parent or the court.

### HCR 2002/SCR1001

Ratifies the Equal Rights Amendment to the U.S. Constitution with the primary purpose being to enshrine abortion rights.

### HB 2696

Repeals Arizona law ensuring babies born alive following an abortion are given all medical means necessary to promote life for those babies.

### SB 1123

Allows non-doctors to perform surgical abortions.

## End of Life

### HB 2582/SB 1384/SB 1497

Legalizes physician-assisted suicide, allowing a patient supposedly suffering from a terminal illness to obtain a prescription for medication to commit suicide.

## Religious Freedom/ Rights of Conscience

### SB 1550

Repeals laws protecting rights of conscience for pharmacists and pharmacies to not participate in providing abortions.

### HB 2068

Places onerous speech requirements on religiously affiliated healthcare facilities with respect to abortion, euthanasia, and transgender surgeries in an effort to blackball those facilities and medical professionals.

### HB 2707/SB 1545

Prohibits licensed counselors from helping minors struggling with unwanted same-sex attraction or gender identity regardless of whether the minor or parents are seeking the therapy. Unconstitutionally restricts professional speech for counselors and denies parental rights to seek help for minor child.

### HB 2716/SB 1321/ SB 1609

Adds sexual orientation and gender identity to statewide nondiscrimination laws to then be used as a sword to restrict free exercise of religion.
